Chair's Summary of Previous Year: During the past year Councillor Jobson moved away from the parish and Councillor Allan was co-opted on to the council. Mr John Mcgregor will join next month. Councillor Poland was thanked for taking on the task of looking after the Carham Community Website. It has been updated and made more accessible to residents. She has also produced two half yearly newsletters which have been well received. Councillor Court has taken on the role of Play Park Inspector following Alan Cater's retirement. Improvements to the surface of the park have been carried out. Councillor Allan and her helpers repainted Wark Telephone Box and stocked it with books and DVDs etc. for residents to use. The Parish Council is in the process of registering the land around the box in its name. Until the current pandemic stopped many activities, Janet Chubb organised a number of walks towards the end of 2019 which were well attended. Superfast Broadband is now available to most residents in the parish. There are several schemes which can help to improve the coverage for those not yet connected in rural areas such as farms. The council has been working with NCC to provide grit bins at strategic steep roads in the parish. A number of residents raised the issue of Goat Common and the Allotment Gardens, pointing to discrepancies between their deeds and the facts on the ground. The council undertook extensive research and consulted NALC before taking the decision that this was a dispute between private individuals and the parish council should not take sides.
