- Chair's Summary of Previous Year: Due to Covid-19 the last annual meeting was delayed till 245 September 2020. The PC has been meeting virtually via Zoom for the meetings in November, January and March. Many thanks to Cllr Poland for organising these meetings. The Parish Council has applied to register the land around the phone box in Wark. We should have the result by September 2021 and then the area can be tidied up. Cllr Court has taken on the role of Wark Play Park Inspector. This is an unpaid role and we are grateful to him for checking the equipment and carrying our minor repairs. Cllr Poland has again produced two newsletters which have been appreciated. She has also been diligent in keeping up the Carham Community Website. The Parish Clerk sifted through the archived minute book from 1921 -1984 and Cllr Poland wrote a history of the parish, scanned the minute book and posted all the information on Carham Community Website. Cllr Murray has retired from Northumberland County Council and Cllr Mather has been elected in his place as the representative for the Wooler district. He is a local farmer at Haugh Head Farm, Wooler and Yeavering Bell near Kirknewton. He is keen to support the Parish Council and offer advice where necessary. Cllr Billy Potts has retired from the Parish Council after 53 years of sterling service, during which he has fulfilled all the roles on the council. We are very grateful to him for his outstanding contribution to the life of the Parish. The Parish Council has been attempting to reduce the speed of vehicles through Wark, especially timber lorries. Cllr McGregor has done some excellent work in getting the views of residents who live on the B6350 road and liaising with the police and the County Council. This is an ongoing issue. Cllr McGregor has been liaising with Janet Chubb and Philip Bradley of Northumberland County Council about repairing and keeping clear the Public Rights of Way in the parish. Cllr Allan has been working to improve the appearance of Wark village. The Chair concluded by complimenting the Parish Council on their team effort.
