Min 615- County Councillor report- County Councillor M Mather provided the following updates: I am the Portfolio Holder for Highways, which also, covers footpaths, toilets and other services. We are hoping to work with Town & Parish Councils an example is investigating if Northumberland County Council could provide a gov.uk website & gov.uk email addresses for Parish Councils as the current offer from NALC is too expensive for some of the smaller Parish Councils.

Town & Parish Councils will receive a letter in the next week or so explaining how the annual request for 3 priorities for the Local Transport Plan will change to asking for 3 priorities on a 3-yearly basis, starting from September 2025, This will allow Northumberland County Council Highways Officers time to design, develop & deliver the schemes over the 3 year period, However, the quick wins may be delivered in year 1. There will be training available for Town & Parish Councillors as well as Clerks. There will be a small % of the budget retained each year in case unexpected work must be undertaken for health & safety reasons.

Berwick School Partnership- There was an open meeting at Berwick Academy on 9<sup>th</sup> July where 4 design options for the new High School building were on display.

Bus Service- The lobbying from Carham Parish Council has been noted, Northumberland County Council & Scottish Borders Council continue to hold monthly meetings. We are looking to find a workable solution for the whole of the parish and surrounding area. I hope to have a further update for the September Parish Council meeting.

Min 621- Public Right of Way- Parish Councillors considered the current consultation for the proposed diversion on Public Footpath No 27. Parish Councillors agreed the following response.

The private road needs to be sign posted and the Right of Way needs to be clearly marked at 3 strategic points.

## Min 622- Play Area-

Parish Councillors received the Annual ROSPA inspection report of the play area, which
raised some points however none of the items of play equipment are deemed unsafe, but
some play equipment is nearly it's end of life.

- Parish Councillors noted that the play area is not well used and agreed that the options for the future of the play area need to be investigated.
- Parish Councillors asked Parish Councillor J McGregor if the Wark-on-Tweed Charity would consider replacing some of the play equipment, suggesting if this was not an option the Parish Council may need to consider what options are available to the Parish Council.
- Parish Councillor J McGregor agreed to investigate the request and told the meeting that Wark-on-Tweed Charity had submitted a Community Asset Transfer request to Northumberland County Council for the land, stating that locally we do not wish to lose the asset.
- Parish Councillors agreed the payment of £96 to Playsafety Ltd for the Annual ROSPA inspection for the play area.

## Min 623- Defibrillator- Parish Councillor V Poland provided the following updates:

- The late Agnes Changleng was the Treasurer for the Carham Parish Defibs.
- The committee had managed to access electric power for the West Moneylaws & Carham defibrillators; therefore, the committee are purchasing 2 defibrillators.
- The next fundraising event is on 20<sup>th</sup> July at the Cornhill Village Fair.
- We need an electric access point for the Wark defibrillator and Northumberland County Council are asking for approx. £1k to use a streetlight. County Councillor M Mather agreed to ask about the possibility of using a car charging point.

County Councillor M Mather agreed to run a training session in the summer, if he was available.

- Min 624- Speed Warning Sign- Parish Councillor J McGregor read out the update he had received from Swarco and questioned that he did not think there had been a visit by the engineer recently. Parish Councillors agreed that Parish Councillor J McGregor should continue to take the lead on this project.
- Min 625- Parish Council noticeboard- Parish Councillor D Wells advised the meeting that the local Men's Shed group had advised him that due to the current condition of the noticeboard it will need to be rebuilt, which will cost approx. £80.

  Parish Councillors agreed to accept the quote of £80 to rebuild the noticeboard. Parish Councillor D Wells to continue to take the lead on this project.
